Membership Terms & Conditions Including Online Payment Option

This page (together with the documents referred to on it) tells you ("you" means the individual reading these terms and conditions) the terms and conditions on which the European Society for Artificial Organs (ESAO) offers subscriptions for membership, which is to be read in conjunction with the statutes of ESAO http://www.esao.org/about-esao/statutes/. If there is any inconsistency between any of the provisions of this agreement and the statutes, the provisions of these terms and conditions shall prevail.

Please read these terms and conditions carefully before applying to become a member of ESAO. You should understand that by applying to become a member of ESAO, you agree to be bound by these terms and conditions.

1. New Membership Applications

To become a member of ESAO, please fill in the following form http://www.esao.org/membership-application/ and submit it by email to Anita Aichinger ESAO Office@donau-uni.ac.at or by regular mail to ESAO Office, Danube University Krems, Dr.-Karl-Dorrek Str. 30, 3500 Krems, Austria. Please note that all future communications and membership documents will be addressed to you according to your address on the online or paper application form.

Joining as a member builds a contract between you and ESAO after your registration has been completed, full payment has been received and a preliminary confirmation of membership has been emailed or sent by regular mail to you. Please note that according to our statutes, your membership has to be confirmed during the General Assembly of ESAO that takes place during the annual congresses in September. In case your membership application is turned down by the General Assembly, ESAO will return the membership fee to you.

2. Membership Renewals

3. Categories of Membership

ESAO offers different types of membership for individuals as full member, junior member, young ESAO member and group members with and without subscription of the journal of the society (International Journal of Artificial Organs) either as online only or as online and printed version. 4. Benefits and Rights of ESAO Members

ESAO membership entitles you to participate at the annual congresses and schools at a reduced fee. Your membership will also make you eligible to participate in the activities of the different working groups of ESAO (see details here http://www.esao.org/working-groups/

After receipt of the annual membership fee before the end of the preceding year, ESAO Office will inform the publisher of the International Journal of Artificial Organs, that you receive online access or a printed version of the journal if your type of membership includes the journal. In case of delayed payment of membership fee your online access to or receipt of the printed issues of the journal will be delayed.

5. How to Pay

Ensure that your name and ESAO membership number is included as reference number. Your membership application or renewal will not be processed until full payment is received.

Please note that for membership applications we do not accept payment in cash or payments in any currency other than Euro.

Please note that if you do not provide accurate details or if your credit card company does not authorize payment, your application or renewal of membership will be turned down. ESAO will not accept any liability for costs incurred as a result of applications deemed void in this manner.

ESAO reserves the right to request further evidence to support your application.

6. Cancellation of Membership

For online applications, this will be the day on which you are notified by email that your membership registration has been completed. For other methods of application, this will mean 14 working days from the date you receive the letter confirming your membership through the ESAO office.

You can notify us of your wish to cancel your new membership by email in writing to ESAO Office at ESAO Office@donau-uni.ac.at within 14 days as lined out above.

If you wish to cancel your membership, ESAO will refund the full cost deducing any expenses for online payment, bank transfer or receipt of the journal. If payment was made by credit card, refund will be transferred to the same card.

The above cancellation rights only apply to new membership applications and do not apply to renewals of existing memberships.
